





## Launch of PPP legacy hub.

Continuing research & development into coastal habitat creation (Marineff and BU), events will include Discovery Bay and Hullabaloo in Sandown Bay and Under the Pier in Ryde.

Results of Winter 2020/21 Monitoring work (this was scaled back this year, due to COVID restrictions).

Isle of Wight Council Island Planning Strategy draft for public examination provisionally 2022.

We hope to be collecting the data from a National recreational fishing event in July. Forty boats and about 120 anglers. We will collect fish, location data.

SGL will be submitting a planning application in Jul 21 for the development of Marchwood Port. This will seek to make greater efficiency and effectiveness out of the already operational port but developing undeveloped areas and improving surfaces within the port.


I think the Solent Forum's Kate and Karen are doing a brilliant job!
