### 1 Introduction

The Solent Forum publishes a business plan every 5 years; the plan is widely consulted with its members and approved by the Solent Forum Steering Group. As well as the Business Plan, the Forum agree an annual work programme each February with its Steering Group and undertakes annual Horizon Scanning in June to enable any adaptation in the work programme due to unforeseen events. The Forum publishes an Annual Report each March to show its work.

The 2025 to 2030 Business Plan is under development and as part of the business planning cycle a review is required of the previous (2020 – 2025) Business Plan.

Firstly, this review focuses on the Business Plan itself and examines the success of actions achieved. The plan set a timed programme of specific work which was relevant and achievable; this ensured the objectives were Specific Measurable Achievable Relevant and to a Timescale (SMART). The review findings are illustrated by a traffic light system where **green**, signifies fully achieved, **amber** signifies partially achieved and **red** signifies not yet achieved.

Secondly, the review provides a discussion on how to shape the 2025 – 2030 Business plan, looking at the sections headings and identifying priorities for this business plan period, to start to shape it.

### 2 Summary

The Solent Forum enjoyed a successful period between 2020 and 2025 during which it achieved all its core aims and an unprecedented number of projects.

The Forum increased its membership base from 51 to 58 members and members' meetings have been increasingly popular and well attended.

The Forum introduced annual Horizon Scanning, and this has been a useful tool to identify how members can work together in a fast-changing environment.

The Solent Forum works closely with the Solent Seascape Project and chairs the Seascape Recovery Plan Working Group. This plan aligns closely with the work of the Solent Forum's Natural Environment Group, and it is anticipated that the Forum will focus on this work over the next 5 years.

The Members' Survey will help the Forum shape the 2025 – 2030 Business Plan. It is anticipated that it will be similar to the previous plan but will be written in a style which further helps market the Forum and will include case studies of the benefits of the Forum. It will include some new headings, a sustainability forecast and horizon scanning.

### 2.1 Solent Forum Aims and Objectives

The Solent Forum aims and objectives are as follows:

- To promote, facilitate & support integrated planning & sustainable management of the Solent
- 2. To provide a broad-based consultative forum

### **Objectives**

1. To raise awareness and understanding of the members' roles and aspirations

- 2. To improve sharing of the information base
- 3. To facilitate better communication, consultation, and liaison
- 4. To raise awareness and understanding of the human and natural changes likely to materially affect the Solent area and its interests.
- 5. To promote the national and regional importance of the Solent in policy, development and plan making
- 6. To raise awareness and understanding of the impacts of Climate Change on the Solent and appropriate mitigation, resilience, and adaptation measures.

### **3.1** Core Work Programme

### 3.2 Serviced Sub-Groups

The Solent Forum services two groups which are set up by the discretion of its steering group. Solent Marine Sites (SEMS) has its own management group and is financially independent.

The Solent Forum continue to run the Solent Marine Site scheme of management providing the secretariat and its associated Natural Environment Group. These two proactive groups have led to many projects that the Forum has been involved in, many of which has enable the Forum to take in income to cover its costs. All of projects and events that derived from these groups are listed in table 3 on projects.

### 3.3 Projects and Events

#### **Events**

### **Projects and Services**

The Solent Forum managed or has been highly involved in an unprecedented number of projects over the last 5 years totaling 14 projects compared to six projects in the previous 5 year plan period. The following table shows what was achieved against the original business plan. The BUDS project has been the largest project and phase 3 of the project is overdue, mainly as it is proving very difficult to cost and obtain MMO consents.

Building Biodiversity in the Solent Hub	Resource hub on building biodiversity into marine infrastructure. The Forum continues to collate and share further knowledge on this topic.
Beneficial Use of Dredgings (BUDS)	Phase 3, bottom placement dredging at Lymington, including preparation of the MMO Marine License. The Disposal Site Characterisation Assessment is now complete and the MMO Marine License was submitted in June 2024. The final reporting will be undertaken once the license application is determined.
Coastal Consents Guide	We continue to update this Guide when new relevant material is published.
Clean Solent Shores and Seas	The CSSS hub collates and shares information on a range of topics on Solent water quality.

Championing Coastal Coordination (3Cs)	Led by the national Coastal Partnership network to review the future direction of coastal partnerships. The Solent Forum was part of a south coast consortium inc. The Dorset Coast Forum and Isle of Wight Estuaries Partnership. Completed March 2022.
Solent Biosecurity Planning	To raise awareness of marine invasive species amongst Solent stakeholders and help them to adopt biosecurity measures. Workshops were held throughout the Solent and a biosecurity web hub launched in October 2023.
Solent to Sussex Bay Seascape Restoration Inventory	Working with University of Portsmouth to raise awareness and encourage partnership working on habitat restoration. Project completed 2023.
Solent Seascape Project	A Blue Marine Foundation project to restore and reconnect seagrass meadows, oyster reefs, saltmarsh and seabird nesting habitat over five years (2023 to 2028). Solent Forum is a member of the project Steering Group and chair of the Recovery Plan Working Group.
Preventing Plastic Pollution in the River Itchen Estuary	First phase of the project reported all uncontrolled plastics which have the potential for entering the river Itchen, as well as setting up a Steering Group to manage the report recommendations. Solent Forum are part of the steering group.
Solent Nature Recovery	To ensure that coast and marine are embedded in the developing Local Nature Recovery Strategies (LNRS) for Hampshire, Isle of Wight and West Sussex. The first iteration of LNRS' are expected to be submitted to Defra at the end of 2024. The Forum is leading the coast and marine elements with the Responsible Authorities. A stakeholder workshop was held in January 2024.
Sea the Value	Communities and organisations engaged in mapping values and trade-offs, and co-developing green investments for marine biodiversity. The Solent is one of two project field sites and we will be supporting the project team until 2025.

### 3.4 Solent Forum Improvements

In addition to the Solent Forum's work programme, actions were proposed by members to improve what the Forum does.
