




Although I have been a fan of online meetings, perhaps NEG needs one face to face per year due to its nature and importance of discussion.


I would like it if one of the biannual meetings were in-person.

- Applying for funding to develop a Chichester Harbour Investment and Adaptation Plan

- Policy changes to support increased offshore renewables may impact the area, though likely less so than in other areas of the country.
- Clearly the Freeports approach needs to be tracked carefully to see what changes under the new Government. Significant changes to planning rules are anticipated.
- On-going work to decarbonise the marine sector and to protect wider areas of biodiversity will both be significant drivers of change in the area.
